RESOLUTION Proposing Amendments to the Constitution of

the Commonwealth.

OF PUBLIC DEBTS.

OF PUBLIC DEBTS. SECTION 1. The state may contract debts, to supply casual deficits or failures in revenues, or to meet expen-ses not otherwise provided for ; but the aggregate amount of such debts direct and contingent, whether contracted by virtue of one or more acts of the general assembly, or at different periods of time, shall never exceed seven hun-

by virtue of one or more acts of the general assembly, or at different periods of time, shall never exceed seven hun-dred and fifty thousand dollars, and the money arising from the creation of such debts, shall be applied to the purpose for which it was obtained, or to repay the debts so contracted, and to no other purpose whatever.² Sucrios 2. In addition to the above limited power the state may contract debts to repel invasion, suppress in-surrection, defend the state in war, or to r deem the pre-sent outstanding indebtedness of the state : but the mo-ney arising from the contracting of such debts, shall be applied to the purpose for which it was raised, or to re-pay such debts, and to no other purpose whatever. Sucrios 3. Except the debts above specified, in sec-tions one and two of this article, no debt whatever shall be created by, or on behalf of the state. Sucrios 4. To provide for the payment of the present debt, and any additional debt contracted as aforesaid, the legislature shall, at its first session, after the adoption of this amendment, create a sinking fund, which shall be sufficient to pay the accruing interest on such debt, and annually to reduce the principal thereof by a sum not less than two hundred and iffy thougand dollars ; which sink-ing fand shall consist of the new annual income of the public works, from time to time owned by the state, or the traceds of the sale of the same, or any part there-of, and of the income or proceeds of suc of stocks owned by the state, together with other funds, or resources, that may be designated by law. The said sinking fund may be increased, from time to time, by assigning to it any part of the taxes, or othar revenues of the state, not required unless in case of war, invasion or insurrection, no part of the said sinking fund shall he used or applied otherwise than in extinguishment of the public dept, unit the amount of such debt is reduced below the sum of five mil-lions of dollars.

of any portion of its present indebtedness. SECTION 7. 


