FRESH MAPLE MOLASSES.—A correspondent of Field Notes gives the following: Maple molasses, well made, and put in cans right from the kettle, and hermetically sealed, as you would can and seal fruits, will keep as fresh as when bottled from the sap; and this is decidedly the best plan for keeping, as when made in cakes, if exposed to the air, it will lose somewhat of the peculiarly delightful flavor for which it is so prized, and is often injured by insects. All this is obviated by canning while hot. To many families who do not make on a large scale, this need be but a little expense, as the cans that have been used through the winter can be used until autumn fruits demand them again. Put up your best in this way. Where large quantities are made for market the buyer's must select and can for themselves.

DEAD BODY FOUND.—Quite an excitement was raised in Geneva on Sunday last, occasioned by a report that a man had been drowned in the cistern attached to the Medical College. It seems that near the close of the last term at that college, a subject was procured from Albany to experiment on just before the closing term. Some one of the students, it is supposed, wanted to be smart, or had a little grudge against the principal, entered the building on the night previous to the day when the body was to be dissected, and stole it, and at a thing has been heard of the whereabouts of the subject until it was discovered in the cistern on Sunday last, by a boy who happened to lift the lid of the cistern, and discovered the body floating upon the water. Everybody of course supposed that some person had been drowned, the alarm was given, and the news spread over the college like wild-fire, but as soon as some of the village faculty found out that what was going on, the body was soon made way with, and the excitement died away.

PARTICULAR JAIL DELIVERY.—The Toga County Jail Delivery: Hiram S. Steele, committed two or three weeks ago on a charge of larceny, let him self out of the jail yesterday morning about one o'clock, in a very singular way. He occupied a cell in company with another prisoner, who says that during the previous day, Steele procured an iron bar, about six feet long and two inches in circumference, which he framed in the stove, and with which he buried the beam or rafter which held one side of the iron cased skylight. This done, he tore away the lath and plaster to make a hole large enough to crawl through. He then tore two pairs of sheets, (his own and those of the other prisoner) tied the sheets together, and having reached the roof, fastened this rope and let himself down to a high wood pile and thus escaped. The other prisoner says that Steele threatened to kill him if he made a noise. Steele is about forty years of age, over six feet high, black hair, a little stoop shouldered. The remains of Corporal REINHARD were brought home by his uncle, Lieut. A. J. FESSLER, of the same company, and interred at Newberry, on Saturday last. The death of Wm. B. REINHARD—one of the mortally wounded—has since been announced.
