The dwelling house of T. J. HAZZ, at Gatesburg, Ill., was discovered to be on fire on the afternoon of the 1st inst., but the flames were quickly subdued by the firemen. The loss was but \$200, which was covered by insurance. Mr. HAZZ was fortunately a resident of Smithfield, in this county.

The Railroad between this place and Waverly has not been damaged by the high water. Trips have been made every day, though not on the regular time. The embankments in some places where they were new, had been washed, making great caution necessary, to prevent accidents. In a day or two, all will be right again.

One of the patients at the Inebriate Asylum, at Binghamton, a few days ago, escaped in a canoe, and was not seen until he was brought back to the asylum, and returned to the Asylum in that condition. While one of the keepers was trying to secure him in a room the drunken man drew his knife and stabbed him. The injury will probably prove fatal.

The apprehensions of a disastrous flood, founded upon the immense depth of snow in the woods, has happily not been realized. The ice moved in the pond of the dam, on Saturday, without doing damage, and the snow, which has not risen any higher than last spring, being some 5 feet below the high water mark of 1885. We do not hear of any damage by streams in this County.

SCHOOL HOUSE BURNED.—A school house in the village of Newark Valley, was destroyed by fire on Friday night, or rather Saturday morning, the 29th ult. It is supposed that some rude boys had made it a rendezvous for gambling, and other improper purposes. This was as good a school house as there was in that town, and we hope its destruction will lead to some organization for the benefit of the village.—Owego Times.

SAW MILL BURNED.—NATHANIEL MOON'S saw mill, 5 miles south of Owego, in the town of Nichols, was set on fire about 12 o'clock on Saturday night and entirely destroyed. Loss about \$1,500; no insurance. The incendiary, GEORGE LAYMON, was tracked through the snow, from the mill to his father's house in Windham township, Pa., by H. N. MOON, and some others, where he was arrested, and is now in the jail in this village. Persons to act as catalysts to the fire, a quantity of catalytic tools from it. The Lehigh Valley Railroad Company's North Branch Extension, building under the charter of Pennsylvania and New York Canal and Railroad Company, between Wilkes-Barre to Pittston at the south end, 10 miles, and between Towanda and Waverly at the north end, 16 miles, leaving uncompleted, but progressing, 76 miles between Pittston and Towanda.

It will be seen by twenty-eight per cent. of the entire North Branch division is in operation. When the whole division shall have been opened to traffic, the Lehigh Valley Railroad Company will operate 206 miles of main line, from Easton to Waverly, besides its Beaver Meadow and Mahanoy branches. And as the cars of the Lehigh Valley Railroad Company will run north and east to tidewater, the lake and south operations, bounded by the sea and by the lakes, contains an immense population.—Perry's Mining Register.
