Ed. Reporter - In the report of the last teachers institute in this County the question was presented whether School Directors ought to hire their own relations as teachers in the several districts in this County.

With your permission I will say a few words on the subject; and first, let me ask a few questions: Are not School Directors more inclined to hire their own relations than to hire others equally well qualified?

Are they not willing to pay them better wages? Are they not more anxious to hinder their faults? Or, in other words, are they fit persons to sit in judgment on their merits either as scholars or teachers? If regard to their reputation. Has not common sense as well as common law and common justice decided against such a principle of action long time ago?

Why should school directors form an exception to the universal law? If a sub-district unanimously or a majority require the services of a relative of the directors or even of the director himself, perhaps no one ought to object, provided that the person has the requisite qualifications for the school.
