Their method seemed to preclude the possibility of error, but we have recently learned by a letter from the Treasurer of the Pennsylvania State Railway, that the system was not so perfect as it appeared.

due for the month is ascertained, the cash is sealed up in an envelope, and numbered to correspond with the name on the book, and given to the pay-master, who makes monthly trips over the road, and hands the envelopes out to the men entitled to receive them. If the men are indebted for board, the amount is retained and sent by check to the person to whom it is due. Mr. RICE, the bookkeeper in question, it appears, had been in the habit of adding to the number of days returned by certain men, and charging each over-board to balance the amount so over-charged. The board bill was regularly checked and drawn, by the party fraudulently claiming it.

Thus, if JOHN SMITH worked 2 days in April, at \$1.00 per day, he would be entitled to \$2.00. Mr. RICE's plan of operation was to add say 20 days to SMITH's time, and charge him with board \$38; the latter amount would be sent to the boarding-house keeper, who was in collusion with the bookkeeper.

The other day, Mr. WILHELM, while paying the men and examining Mr. RICE's account, discovered some discrepancies which he asked RICE to explain. The latter not being able to do so satisfactorily, a warrant was issued, and the suspected party arrested, who afterward made a full confession of his guilt.

Great credit is due Mr. WILHELM for his agency in ferreting out the matter.
