**The most interesting performance** of the evening was the dramatic readings of FREDERICK COLTON, of Philadelphia. This celebrated reader has been in the service of the results of a long and thorough course of training under the best masters of the art. His readings were so convincing as to draw forth a brilliant reputation as a dramatic reader. "By Nature a genius," by earnest study and practice, an artist," was well said in New York some years ago, and the selection was well suited in style, but her rendition of MARY STUART, by SCHILLER, probably gave the highest praise to her dramatic talents. The entertainment netted about \$100.
