The Order has an endowment rank which pays on the death of a member to his wife, \$1,000, as stipulated, for the benefit of the deceased member's family. This is a safe and cheap form of life insurance, which is rapidly gaining in popularity.

While speaking about "Platform and Stage," Miss DICKINSON has said, "To me the most profitable of all tasks under the sun is the stringing together of words, the combining of sentences, particularly in the face of an audience, without once impelling cause and sufficient motive. In one word I do not believe in talking unless I have something to say. To me the platform should be a species of life pulp; not merely a vehicle of entertainment, but something that ought to be used when one has something pushing or strongly from head and heart that it must find outlet."

Her experience as an actress brings her to say this: "Through all the years of my Quaker training, through all the years that have followed, looking at this life which seems a life of sin, I thought I understood what society had to feel and say. I have found knowledge reveals deeper depths and experience shows in clearer light than anything one can read and hear; so then the long and short of the matter is, you say, 'You have come here to do a bad cause.' No! I am here to magnify a good one. The Stage? Even so."
