Profit of Feeding Corn to Hogs.

It is estimated, from an experiment made by S. B. Anderson, that 100 bushels of corn will produce 1,056 pounds of gross increase in the weight of hogs...

It thus appears that one bushel of corn will produce a gross increase of 10 1/2 pounds. Throwing off one-fifth to come at the net weight, gives 8 1/2 pounds of pork...

From an experiment made by Samuel Linn, with 53 hogs, as reported in the Patent Office Report for 1849, 6 1/2 pounds of corn produced one pound of pork.

From the experiment of the Hon. H. L. Ellsworth, reported in the Patent Office Report for the year 1847, it appears that 3 1/2 pounds of cooked meal made one pound of pork.

Assuming that it requires 6 2/3 pounds of corn to make one pound of pork, the cost of its production will be seen by the following table.
