## General Grant Restoring Safety and Order in Mississippi.

A recent order of Gen. Grant, after announcing that all regularly organized bodies of property have been driven from these parts of Kentucky and Tennessee west of the Tennessee river, and from all of Mississippi west of the Mississippi Central Railroad, declares that the most rigorous penalties will hereafter be inflicted on the following classes of prisoners, to wit: Rebels and their bodies or cavalry not mounted and paid by the Confederate authorities; all persons engaged in conspiring, enjoining, the conscription, or apprehending deserters, whether regular or irregular; all citizens encouraging or aiding the same; and all persons detected in doing any of the above.
