A public meeting of the iron, glass, steel, cotton, copper and other manufacturers, as well as all consumers of coal, was held yesterday afternoon in the Board of Trade Room, to take measures to meet the price of coal. Mr. George D. Jones, General President, Mr. Alex. Chambers and Alex. King Vice President, and Messrs. James M. Bailey and F. J. Herren appointed Secretaries.

After stating the object of the meeting, it was voted to call a meeting of coal dealers, after the interchange of views on the subject, to be held at the Hotel Duquesne, on Tuesday evening, at 8 o'clock.

The Committee, after a short absence, reported the following, which was unanimously adopted:
