CONSTITUTIONAL PROVISIONS

Article I, Section 2, Clause 3: The House of Representatives shall be composed of Members chosen every second Year by the People of the several States.

ARTICLE II, SECTION 1

Section 1: The executive Power shall be vested in a President of the United States for a Term of Years.

ARTICLE III, SECTION 1

Section 1: The judicial Power shall be vested in one Supreme Court, and in such inferior Courts as the Congress may from time to time ordain and establish.

ARTICLE IV, SECTION 1

Section 1: Full Faith and Credit shall be given in each State to the public Acts, Records, and judicial Proceedings of every other State.

ARTICLE V, SECTION 1

Section 1: All legislative Powers herein granted shall be vested in a Congress of the United States, which shall consist of a Senate and House of Representatives.

ARTICLE VI, SECTION 1

Section 1: This Constitution, the Laws of the United States, and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land.

ARTICLE VII, SECTION 1

Section 1: The Ratification of the States which shall have reached a Majority shall be the Act by which the Constitution shall be established.
