WASHINGTON CORRESPONDENTS. We are reminded, as we write, of the difficulties and troubles of a Washington letter writer, by finding in one issue of the Cincinnati paper from which Mr. Chase would not and could not be expected to write, while another page contained the announcement that he had been appointed.

Indeed this appointment illustrates how very little these Washington correspondents really know of what is going on there; for up to the very hour when the nomination was sent to the Senate, the correspondents of nearly every paper in the country were writing and telegraphing (as they had been for weeks) that Mr. Chase was out of the question altogether. There are always in Washington men who pretend to know all that is going on, and have "the ear of the President," and to possess the utmost intimacy with him. They wear a very knowing look, and shake their heads significantly, sometimes saying what they think and at other times darkly hinting it, but always impressing the beholder with the idea that what they do not know is not worth knowing. The correspondents have been victimized by these fellows, this time, as they have been many times before.

President Lincoln is a remarkably intelligent man, and does not make known in a random way what he is going to do. He listens patiently, thinks carefully, and acts deliberately, but does not talk about his purposes except to those whom he can trust, and hence the correspondents are all at fault in trying to forecast his future action. We feel much regret that in this case he has proven himself so much more astute than they; and that in making their false prophecies he has shown himself a true man.

Certainly if experience and steel worth could be made of his qualifications for such a place, he is just the man for it.

We suppose, from the manner of organizing this corps, that the appointment will be made to depend somewhat on the success made to get recruits. As between two persons of the same ability, he will be preferred who has done the most to raise men. In this way, companies will be formed, and regiments and brigades will be organized. It is not likely that any one of the Pennsylvania regiments will be organized, she should, she will get a Brigadier from among those best qualified who have been most active in raising it. Colonel Swartz can, we think, be made most effective and successful in carrying the needed recruits; and his appointment will need no better or other backing.
