Confusion at the Monongahela Wharf. Two Tug-boats Destroyed and Two Fired.

About ten minutes after two o'clock on Sunday morning a fire was seen leaping from the tug-boat "River Queen," lying at the foot of Market street. The first alarm was given by a man who soon stated the vessel steamboat bell to ringing and a few minutes thereafter a number of eight appeared at the scene. The boat had gained considerable headway before discovered, and almost immediately came up with the vessel, when it was found that both bulks were afire. The flames left nothing but two bulks partially sunken, and filled with a worthless mass of iron and charred wood.

From the "George Alfred," the names long mentioned to Capt. Wm. H. Davis, the commanding officer of the tug, he said that the progress no further than the building and doctoring of the second deck, across which the flames had spread, and that the vessel was almost entirely destroyed, it was rendered perfectly worthless.
