The following is the decision rendered by Judge
Grier on the twenty-second day of September,
1891, in the United States Circuit Court at Philadel-
phia. The case was argued three days by Charles
H. Keller of New York, H. V. Lucas and S. A. Fur-
ber of Pittsburgh, for defendants, and George
Harding of Philadelphia, and George H. Christy, of
Pittsburgh, for plaintiff.

OPINION OF JUDGE GRIER.

As I write with difficulty I can only state the con-
clusions to which my mind has come after a care-
ful examination of this case.

The complainant has exhibited a patent dated
25th of April, 1866. This is prima facie evidence of
a good title, and puts on the respondents the bur-
den of proof that the patent is void or worthless.

I need not repeat my remarks in the case of Good-
year vs. Day (2 Wall, U. S. Reps. 239), but now
accept them as affording a rule of decision which ap-
plies clearly to the present case.

As the infringement of the patent is admitted,
the only question will be as to the validity of com-
plainant's patent of April 25, 1866.

"It was after speculation had been reduced to
practice," and after repeated experiments, that the
complainant succeeded in overcoming the prejudice
and ignorance of the public on this subject, and
persuading the public that his invention was new;
after he had established its great utility and value,
and "when his genius and patient perseverance, in
spite of sneers and scoffs," were completely suc-
cessful, that Reed, who had before made experi-
ments on the same subject, and was unsuccessful,
imagined that he had the best right to the inven-
tion, and after purchasing one of the complainant's tor-
pedoes, he applied on the 1st of November, 1867,
for a patent for substantially the same combina-
tion of devices and machinery contained in com-
plainant's patent. On the 18th of the same month
the respondents formed themselves into a company or
corporation called "The Reed Torpedo Company,"
for the purpose of practicing the complainant's in-
vention, and supporting the expense of litigation,
and thus defrauding him of the fruits. They have per-
sisted, even after the preliminary injunction very
properly granted by the District Judge.

Let a decree be entered for complainant for a per-
petual injunction, and a Master appointed to take
an account according to the order of the bill.

R. C. GRIER, Judge.

NOTE.—The passage referred to by Judge Grier in
his former decision, 3 Wallace, p. 239, adopted as
applicable to this case was as follows:

"It is in equity the case, when any valuable discov-
ery is made, or the probability of great utility is
invented, that the attention of the public has been
turned to that subject previously, and that many
persons have been making researches and experi-
ments. Philosophers and mechanics may have
made measures anticipated in their speculations
and possibly of probability of such discovery or
invention; many experiments have been success-
fully tried, and long series of them, and yet
become a public benefactor and entitled to a patent.
"And yet when genius and patient perseverance
have at length succeeded, in spite of sneers and
scoffs, some valuable invention or discovery, how
seldom is it to be followed by reward? Envy robs him
of the honor, while speculators, swindlers, and pil-
fers rob him of the profits. Envy is worse than
speculation. It has resulted in discovery and when that
discovery has been perfected by patient and contin-
ued experiments, when some new compound, art,
manufacture, or machine has been thus produced,
which is useful to the public, the party making it
becomes a public benefactor and entitled to a patent.
"And yet when genius and patient perseverance
have at length succeeded, in spite of sneers and
scoffs, some valuable invention or discovery, how
