THE

TORPEDO PATENT SUITS.

Roberts vs. Nicholas Geyer.

The following is the decision rendered by Judge
 McKenna, at May Term of the Circuit Court in the
 above case:

In the Circuit Court of the United States, heard for
 the Western District of Pennsylvania—**N. A. L.**
Roberts vs. Nicholas Geyer—No. 1—May Term
 1873—In Equity.

November 18, 1872. Bill filed and returned by
 plaintiff.

Answer and notice of application for preliminary
 injunction served.

December 12, 1872. Motion for preliminary in-
 junction denied, and the Court being duly advised in
 the premises the injunction awarded as prayed for,
 and dissolved.

January 11, 1873. Injunction issued, and on the
 20th day of January judgment served personally
 on Geyer.

May 22, 1873. Bills filed for defendant in this
 cause, which defendant should not issue for contempt
 of the Court's order of the 11th day of January.

June 22, 1873. Motion for attachment in this case
 denied on the merits, and a decree of contempt was
 rendered against the defendant, and the Court being
 duly advised in the premises, the Court ordered that
 the defendant should be imprisoned in the common jail
 of the County of Allegheny for and during the term of ten
 days, and that he pay the costs of this cause.

June 24, 1873. Judgment issued.

The plaintiff in this case was Ed. Ingleton,
 of the Robert's patent of No. 1—issued the 12th of
 1871, for an improvement in the production of oil wells.
 The said Ingleton, for which the defendant was
 awarded for contempt, consisted in using
 a torpedo, for exploding torpedoes in a
 well being the same as of Ingleton's patent for this
 purpose was also included in the case No. 2, No
 10th Term, 1872, as is recited.

The Court in Roberts, J., after directing the
 plaintiff to file a bill of particulars, proceeded to sentence
 Nicholas Geyer for contempt, and directed the fol-
 lowing oral opinion:

In the case of Nicholas Geyer charged with con-
 tempt of Court, I am entirely satisfied that there was
 no present, in the use of the said torpedo, as I have
 indicated in the opinion in the case of the plaintiff,
 the presence of fluid in the well, whether it
 is used or not, is an infringement of the patent, and a
 breach of the injunction of the Court.

Mr. Roberts, by his patent, has secured the prin-
 cipal elements of his invention: Ed. Ingleton, and
 wherever there is fluid sufficient in a well, at the
 time of the explosion of a torpedo, its opening is
 limited, which it sets there naturally, so that
 there is no fluid, but it is not fluid. This is
 exactly the case in regard to the said well.
