Now, therefore, I, Abraham Lincoln, President of the United States, do hereby proclaim and de-clare that the said proclamation does not apply to the cases of persons who, at the time when they seek to obtain the benefits thereof, by taking the cath thereby prescribed, are in military, naval or civil confinement or custody, or under bonds or on parole of the civil, military or naval authorities or agents of the U.Lied States, as prisoners of war, or persons detained for offences of any kind, either before or after conviction, and that, on the con-trary, it does apply only to those persons who, being at large and free from any arrest, confine-ment or duress, shall volnatarily come forward and take the said onth, with the purpose of re-storing peace and establishing the National au-thority. Prisoners excluded trom the amnesty offered in

oners excluded trom the amnesty offered in the said proclamation may apply to the President for clemency, like all other offenders, and their

applications will receive due consideration. I do further declare and proclaim that the oath prescribed in the aforesaid proclamation, of the 5th of December, 1863, may be taken and sub scribed to before any commanding officer, civil, military or naval, in the service of the United States, or any civil or military officer of a State of Territory not in unsurrection, who, by the laws States, or any civil or military officer of a State or Territory not in insurrection, who, by the laws thereof, may be qualified for administering oaths. All officers who receive such onths are hereby au-thorized to give certificates thereon to the persons respectively by whom they are made, and such offi-cers are hereby required to transmit the original records of such oaths at as early a day as may be convenient to the Department of State, where they will be deposited and remained in the archives of the Government. the Government

The Secretary of State will keep a register thereof, and will, on application, in proper cases, issue certificates of such records in the customary form of official certificates.
