Franklin, Pa. May 19.—The Grant House was burned this morning. A lady jumped from a window of the fourth story and died of her injuries. Two servants were missing and it is feared they perished in the flames.

The fire is supposed to have been the work of incendiaries for the purpose of plundering the house. The loss amounted to about \$30,000, on which there is an insurance of \$31,000.

XXXIXth Congress—First Session.

Washington, May 19.—The House of Representatives, in further response to the President's message, reports from the Secretary of the Navy, Secretary of the Interior and Secretary of the Treasury, and whether any have served in the Army.
