

The Recent Storm in Maryland.

BALTIMORE, October 12.—Among the establishments that have suffered more or less by the storm and flood are the following: Gray's Factory, Union Factory, Thistle and Granite Factories, at Elliott's Mills, Albion Factory, at Ebyville. The dams are all destroyed or greatly injured. The Avalon mill and iron works, near the Relay House, on the Baltimore and Ohio Railroad, had their dam broken and the buildings flooded and injured.

BALTIMORE, Oct. 12.—The accounts received from the Upper Patuxent show the damage by the storm to have been much greater than was reported yesterday. The large dam of the Union Manufacturing Company, with a part of its mill-race, graving and horse, together with the bridge connecting it with the main line, more and Ohio Railroad, were all swept off.

From California. SAN FRANCISCO, Oct. 12.—The deflation reported yesterday will amount to \$500,000 in currency. The perpetrator, a book-keeper, has absconded to Chicago or Panama.

Two hundred guns were fired last night by order of the United States Central Committee, for the late political victories.

Another Railroad Robbery. BOWLING GREEN, Ky., Oct. 12.—A gang of six men robbed the railroad office and store at Bowling Green, Ky., at 6 P. M., taking about \$1,500, of which \$1,000 was in cash. They also robbed a large goods store.

THE NATIONAL BANKS.—The law requires the agents of the National Banks in the leading cities of the United States, to redeem the currency of any of the National Banks under certain conditions. One of these agents in Boston refused to redeem a package of a thousand dollars, mutilated currency, because he considered the notes so much destroyed that they were worthless.

POSTAGE TO SWITZERLAND.—Letters and printed matter of every kind posted in the United States and addressed to Switzerland, may be transmitted by the steamer line to Belgium, in the mails made up at New York and despatched by the new line of American steamships running direct between New York and Antwerp.

SMUGGLING IN TEXAS.—The Treasury Department is informed that smuggling operations of an extensive character have recently been carried on from Matamoros to Brownsville, Texas, across the Rio Grande. The withdrawal of troops stationed at Brownsville has given the smugglers an opportunity for effecting their unlawful purposes, which they have been prompt to seize. Measures have been instituted for the prevention of these transactions. Such is the activity of smugglers at the various points of the frontier, that the exercise of the greatest vigilance is required from revenue officers in the performance of their duties.

FOOLISH BUT TOUGH.—The other day an old man, seventy years of age, threw himself from the column of the Bastille, Paris, but falling on the tarpaulin stretched at the base of the column he was not injured. He employed in repairs, rolled thence to the ground, without receiving any apparent injury. He instantly scrambled on his legs, picked up his cap and was deliberately walking off, when the guardsman politely requested him to accompany them to a neighboring guard house.
