

The Retirement of the Commissioner of the Indian Affairs.

At the close of office hours yesterday, the clerks of the Indian Bureau repaired to the room of the retiring Commissioner Cooley to bid him adieu.

Charles A. Mix, Esq., the chief clerk, said that before bidding him farewell, they had deputed him to present a letter as expressive of their sentiments and feelings.

In doing so he observed, that a testimonial of a different character might have been presented, but that the views of the Commissioner in advertising to such matters had induced them to suppose that this would be more acceptable.

He then read the letter, which was elegantly engrossed on parchment, as follows:

DEPARTMENT OF THE INTERIOR, OFFICE OF INDIAN AFFAIRS, Oct. 31, 1866.—Hon. Dennis M. Cooley, for your own voluntary act you are about to retire from the position of head of this Bureau.

Before you leave us we desire to express our appreciation of your uniform kindness and courtesy to those who have been under your supervision, and our regret that a connection which has been so pleasant shall so soon be severed.

It is to you, our long and able Commissioner of Indian Affairs at a time when the duties of the office were never more onerous, more delicate and more difficult, and the energy, ability and integrity with which you have discharged those duties have deserved and received our admiration.

The only testimonial we offer is our names. They may not be enduring, but when you look upon the names of the friends who remember you with gratitude, and who will regard your future career with deep interest, unlinked with any doubt as to its successful issue.

Respectfully and truly your friends, (Signed by all the clerks in the Bureau.) Judge Cooley replied at some length, expressing his great appreciation of the honor conferred, and paying a high compliment to the worth of those from whom he was now about to separate.

He said that during all the long and arduous career of his relations with more than twenty different tribes or nations during his term of office, it had been his good fortune, in every instance, to meet the cordial approval of the Secretary of the Interior, the President, and the United States Senate.

No treaty had been rejected that had been made by him, or during his administration. In severing his connection with the office he was happy to be able to say that he was succeeded by a gentleman of large experience and administrative ability (Colonel Boggs) and under the guidance of such a noble and very accomplished Secretary of the Interior, his administration, with their aid, must be a success, and their relations, he trusted, most pleasant and agreeable.

In the course of his remarks he said: "There is not a hostile tribe of Indians with whom we are in treaty relations on the American continent, and there is no tribe not in such relations with whom it can be said we are at war. Only here and there are outlaws, as there are outlaws everywhere, who commit occasional depredations. These, with vigor and caution, are caught and punished. If justice, and only justice, is now meted out to all, and our treaty stipulations are kept in their spirit by our government, there will never be another Indian war, even though so loudly demanded by army contractors and those who fatten on the spoils of war."

The Fenians. OTTAWA, C. W., October 31st.—Hon. Messrs. McDougall, Campbell and McDonald are expected here to-day. It is thought probable that a Cabinet Council will be held to-day to discuss the matter of the Fenian prisoners. It is not likely that anything will be decided upon until a full meeting of the Cabinet is held at Montreal, next week.

TORONTO, C. W., October 31st.—The Fenian trials were resumed at noon to-day. The judge having called over the jury, John Quinn was first in the dock. R. A. Harrison, McNeil and Kenneth McKenzie for the Crown, and Kenneth McKenzie for the prisoner.

The prisoner's counsel applied for a postponement of the trial, in consequence of the absence of a material witness, who could not be found, and on other grounds. He also stated that he had found great difficulty in obtaining the names of American affidavits set forth that the prisoner had longed in Rochester, New York, and a calculated newspaper had published articles calculated to prejudice the minds of jurors against the prisoner; and that the (jurors) never had intimation of the nature of the evidence against him, and until recently had been desirous of the means of making inquiry as to the evidence. The prisoner further believes that he will be ready for trial in January next.

Mr. McKenzie urged that the delay should be granted. Mr. A. Harris contended that as to-day was the day that the prisoner had stated that he would be ready to go to trial, and as the Crown had been to a great expense, and the convenience to keep the witnesses here, the grounds set forth in the affidavit would not warrant the application for a postponement. The judge, upon looking over the affidavit referring to them, suggested certain amendments, which, having been made, the application was granted, and the trial postponed until the 13th of next month.

The next prisoner brought into Court was Patrick McGrath, who claimed to be an American citizen. Mr. McKenzie made a similar application for postponement.

MONTREAL, Oct. 31.—At a public dinner to the Hon. J. D. Carder, last night, General Sir John Michel, commander-in-chief, made a speech recommending the fortification of Montreal, Kingston, and the points west, and also that the volunteer movement be extended over entire British America.

The Canadian papers are discussing Mr. Seward's letter and the tone of the American press, and generally say that the threats of many American papers, who are now on the part of the Government, will do the prisoners more harm than good, and quote the hanging of Captain Beale, Kennedy and others by the United States during the late war.

The Baltimore Police Commissioners. BALTIMORE, October 31st, Midnight.—The investigation of the charge against the Police Commissioners was continued until two o'clock this afternoon, when the counsel for the defence announced that they were through.

A recess was then taken until four o'clock when the counsel commenced arguing the case. At about ten o'clock to-night, the argument was concluded.

Mr. Alexander, in the course of his argument, said, "No matter what might be the decision of the Governor, the Commissioners had determined, before the coming election to appoint one Conservative Judge of each precinct, not because there had been any objection on the part of the Judges at the recent election, but because they desired to avoid every cause of dissatisfaction that might exist."
