THE PROTESTANT EPISCOPAL CON-VENTION.

This Morning's Proceedings. This Borping's Proceedings. The Convention of the Protestant Episcopal Church re-assembled in St. Luke's Church this morning. After Morning Prayer the Convention was promptly called to order at 10 o'clock. The number of listeners assembled 10 0 010CK. The number of insceners assumbled was much larger than on vestorday. Bishop Stevens was in the chair. The roll was not called. On motion to that effect, the rule was suspended. Such being the case, no addition took place to the number of delegates in attendance.

in attendance. After reading and adopting the minutes of last night's session, nominations were made to fill clerical and lay vacancies in the Standing

Committee. The nominees were Dr. Benj. Watson, Revs. Thomas F. Davies, E. A. Foggo and J. Percy Brown, Messrs. R. R. Montgomery, Chas. E. Lex and Joseph S. Whitney. Rev. Mr. Foggo withdrew his name. The clerical tellers were Rev. Dr. Wadleigh, A. A. Marple and A. P. Brush. Lay tellers, Messrs. L. Cofin, A. Ricketts and P. Baldy, Jr.

Rev. Dr. Paddock-offered a resolution that the Convention meet next year, on the third Tuesday in May, in St. Luke's Church, in this

city. Mr. Hunter moved to fix the second Tues day as the time of meeting. Rev. Mr. Pratt moved a further amendment. He wanted St. Andrew's Church as the place

He wanted St. Andrew's Church as the place of meeting instead of St. Luke's. Rev. Doctor Drumm offered a resolution that the religious services of the next Conven-tion be held in St. Luke's Church, but that the tion be held in St. Luke's Unurch, but that the business of the Convention be transacted in some public hall, to be chosen by a committee appointed for the purpose. The Doctor thought that the holding of a business meeting in a house consecrated as a temple of God was out of place, and that scenes sometimes oc-curred in the course of the business. harmless curred in the course of the business, harmless in themselves, but violatory of the purposes for which our churches are dedicated, as temples for the worship of Almighty God. Another delegate objected to this. The scope or conduct that would be improper in a temple of ford would first daile a fit temple of temple of God would first defile a "temple of

the Hoiy Ghost." The Bishop called attention to the fact that the first two days of the Convention are so oc-cupied in religious services as to render the proposed removal at least inconvenient. This amendment was lost. Dr. Paddock's motion, as amended by Mr.




