

THE NEUTRALITY PROCLAMATION.

WASHINGTON, Aug. 22.—The President has just issued a proclamation, which follows in substance: "Whereas the President of the United States is bound to observe the law of nations in that behalf."

Now, therefore, I, Ulysses S. Grant, President of the United States, do hereby declare that it is the duty of every citizen of the United States to observe the law of nations in that behalf."

The following acts are forbidden to be done under penalty within the territory and jurisdiction of the United States: First—Accepting and exercising a commission to serve either the belligerent party or by or for either of them.

Second—Entering into the service of either of the belligerent parties as a volunteer or as a marine or seaman on board of any vessel of war, or as a privateer.

Third—Entering into the service of either of the belligerent parties as a soldier or as a privateer, or as a member of any of the armed forces of either of them.
