MORE OF THE DEMOCRATIC FRAUDS.—Be-fore U. S. Commissioner Biddle to-day at noon was arraigned a Democratic candidate for Cherry Hill, who was detected in his endea-Cherry Hill, who was detected in his endea-vors to assist his party by false registration, in order that the "roughs" and "rowdies" of New York and Baltimore might vote thereon at the coming election. The prisoner was ar-rested on a warrant issued on the oath of Daniel B. Beitler, one of the canvassers of the Sixth division of the Ninth Ward, who testified that John A. Armstrong, alias John A. Reilly, alias Patrick Mann, had registered himself by false and fictitious names. Daniel B. Beitler, sworn-I assisted in the

registry of Jno. A. Reilly, No. 1603 Market street. The prisoner is the man. On the 19th street. The prisoner is the man. On the 19th of September he came in to our place and asked to be registered he was qualified, and told that any statement made; was under oath. He said that he had lived at 1603 Market street for eight months past. Several questions were propounded, which were answered. He stated that he was between 21 and 22 years of age. He got his certificate and left. A few minutes afterwards, two other parties came to be registered, and stated that they lived 1609 Melloy street; we examined the list and found that a policeman, named McConnell, lived there; arefused to register

McConnell, lived there; strefused to register them; afterwards saw Reilly in company with them; I told my brother canvasser, Mr. Cook them; I fold my brother cantasser, an. Cook man. to watch them; I then went to 1603 Market; there I found that John A. Beilly had never lived there; I arcsted Reilly at the fourth precinct of the Mnth Ward on the same atternoon; he was endeavoring to get re-gistered; Mr. Thompson was one of the can-

wassers. Mas. S. Thompson, sworn-I am one of the canvassers of the fourth division of the Ninth canvassers of the fourth division of the Ninth Ward; I recognize the prisoner; he came there to get registered with a boy; I told him to clear out; I further told him to get two householders as vouchers; he said he would get his father; he said his father resided at-the Smedley House, 1227 Filbert street, he said he resided there with his father; a lad named Sleeper was with him; Sleeper, who was registered, went to the bar alterwards with Reilly and said he was only a boy. Engle, swoin-I am one of the canvassers for the third division of the Ninth Ward; the prisoner applied to us for registration on age; he said his name was Armstrong/ and that he lived 1026 Filbert street, a few doors below the Precinet House ; we refused to register him without the proper vouchers being produced; it was the day before he was arrested: we have since inquired and found that the prisoner did not reside at 1026, but that another gentleman named Armstrong

Wm. Patterson, sworn-I am one of the canvassers for the Eighth division of the canvassers for the Eighth division of the Ninth Ward; I recognize the prisoner as the person who was registered under the name of Jas. Reilly, paper hanger. No. 38 North Twenty-fifth street; born in New York in 1849; on age; I subsequently found that such a person had resided there about a day, and had left very suddenly.
