FARM AND HOUSEHOLD ITEMS

Fattening Cattle.

Mr. Bela S. Hartings, who is one of the leading drovers from Vermont, in supplying the Boston market, gave his experience and observation in relation to fattening stock, at a late meeting of the Caledonia County Farmers' Club: He said the main object of the farmer was to get the most out of his fodder. It does not pay to feed grain to a poor creature, one that does not take on flesh rapidly. Farmers will do better to dispose of such stock for what it will bring, and procure animals of good style. He believed that one-half of the grain fed was wasted by not being fed to good cattle. Another important point is, farmers do not feed heavy enough. He would commence with as much feed as they would bear first, and then increase. In feeding twelve quarts of meal, the last four quarts are worth twice as much as the first four for fattening purposes. Some farmers complain that they do not get pay for the grain they feed out, but he noticed that it was only those that fed light that thus complained. Whether the animal was to be fed a long or a short time, he would recommend heavy feeding. Mr. Hartings said he knew nothing better than corn meal. The cob is not worth much, if anything. Those persons of whom he purchased fat stock, who were the most successful, and made it most profitable, were those who fed meal largely. If a farmer has potatoes or other roots, it is well enough to feed those in part, but a farmer will do better to exchange some of his roots for corn, than to feed roots altogether. It is important to feed regularly and not too often, as the stock will eat and lie down and ruminate. It is better to feed cattle but three times a day, and sheep but once.

Marketing Grain.

We have occasional inquiries as to the propriety of disposing of grain as soon as ready for market, or of holding for a rise later in the season. We cannot with propriety advise in a matter on which so many men have widely different ideas, yet there are some circumstances in which the farmer may find himself in doubt as to which course should be followed, and make a man's interest apparent. First. A farmer should go to market without loss of time when other parties have an interest in his crop. If the merchant has been promised a part of the proceeds, it is only strict honesty to fulfil the promise at the earliest day. Second. It is never wise for a farmer to borrow money rather than sell his crop. He will afterwards keenly regret this course. The anxiety of the speculator will consume him, and even should he succeed in gaining an advance, the cost of interest will doubtless eat it up. If a farmer has money in hand and grain in his barn, he is independent of contingencies, and can do as he pleases; but for all others, we think the sooner they go to market the better.—Hearth and Home.

Peaches Without Stones.

An agriculturist has, it is said tried with success the following method of making peaches grow without stones: "Turn the tops of the trees down, cut off the ends, stick them into the ground, and fasten them so with sticks; in a year or two these tops will take root, and when rooted cut off the branches connecting these reversed and rooted branches with the tree proper, and this reversed peach tree will produce fine peaches without stones." The same experiment may be tried with plums, cherries, and currants.

Peach Butter.

Pare ripe peaches and put them in a preserving kettle, with sufficient water to boil until soft; then sift through a colander, removing the stones. To each quart of peach put one and a half pounds of sugar, and boil very slowly one hour. Stir often and do not let it burn. Put in stone or glass jars, and keep in a cool place. Plums are very nice prepared in the same way.

A Good Pie.

The following receipt for making a good pie is worthy of dissemination. In half a teacupful of vinegar put one table-spoonful of butter, one teacupful of molasses, one teacupful of dried currants, one egg and a little nutmeg. Roll two soda crackers fine and add to the above, and you will have material enough for three pies. Try them and you will make more.

To destroy moths in carpets, wring a course towel out of clean water; spread it smoothly on the carpet, iron it dry with a good iron; repeat the operation on all parts of the carpet suspected of being infested with moths; no need to press hard, and neither the pile nor the color of the carpet will be injured, and the moths will be destroyed by the heat and steam.
