PANAMA, November 9.—A despatch from Kingston, dated November 8, reporting the capture of the Virginians and the execution of the four prominent patriots, says it is rumored that Ryan and Veeber, not dying easy, a Spanish officer thrust his sword through Ryan's heart, and that the blood, thirty inches, severed their heads from their bodies, placed them on pikes and marched through the city. The Virginians are reported sunk at St. Jago. There is great excitement here, Panama, where Ryan was so well known.

The Tweed Verdict. New York, Nov. 20.—The contents of the newspaper this a. m. on the verdict of the jury in convicting Tweed, the great Tammany chief, are not very far from what we all agree it was the most righteous verdict ever rendered by an American jury, and a great triumph in vindication of law and justice. Much curiosity is expressed to learn whether or not Tweed could be sentenced on the various counts on which he has been found guilty, or whether the big indictment covers all the counts.

On Wednesday night, last week, two young men, Felix Light and Ephraim Trostle, were guarding the barn of Charles B. Forney, in North Lebanon, against incendiaries. While near together, Light's pistol dropped from his pocket, exploding the charge and sent a bullet into Trostle's arm at the elbow. It is not determined whether the arm can be saved or whether it will have to be amputated.

The true valuation, according to the same authority, of real and personal estate was \$30,968,518,507. In 1860 it was estimated at \$16,159,616,008, true valuation, and in 1850, \$7,135,780,228.

One Branton, of Yolo county, Cal., on a bet of \$50 rode a race on horseback against the California Railroad train bound from Sacramento to Woodlawn. The agreement was that he was to have three minutes start from the Sacramento and Yolo bridge, and race to Davisville, fifteen miles. He rode the horse Honest John, bareback, and arrived at the Depot in Davisville four minutes ahead of the train.

Robert Sixbury died on the 23d Oct., in Leary, Jefferson county, N. Y., aged one hundred and ten years and seven months. He had acquired great reputation as a hunter on Brown's tract in Northern New York, where he had slain over 2,300 deer. When past 80 years of age he met with an accident, which necessitated the amputation of his leg, and he assisted the country doctor to perform the operation without flinching.
