Putting away Potatoes.

Every method has been tried by farmers to store and preserve their potatoes through the winter and we may say until potatoes come again.

In storing potatoes several methods are adopted, yet they are practically the same, the object being to protect them against freezing.

When stored in the field, straight trenches are dug, six to twenty feet in length and four or five wide, which are filled to the depth of three feet with potatoes, then well covered with straw, top of which put eight or twenty inches of earth.
