THE EXECUTION AT SUNBURY.

O'Neil Reprieved: M'Manus Hung.

Sheriff Weaver received the news on the 8th inst. of the reprieve of O'Neil for thirty days, and on the morning of the 9th inst., the day of the execution, O'Neil was informed of the fact, after the celebration of the high mass, by the priests. He was very grateful.

M'Manus ate heartily at breakfast, and declared his resignation to his fate. At about 11:35 he was brought out of the cell, accompanied by the priests and Sheriff. He was asked if he had anything to say, but replied, "Nothing." The drop fell at 11:43. He died without a struggle. About one thousand persons witnessed the execution. The sons of the murdered Frederick Hesser were present at the execution. The affair was very orderly.

O'Neil will have his case brought up once more before the board of pardons, and he will no doubt be recommended for commutation to imprisonment for life.

Sunbury was crowded with people. Several ladies, who witnessed the execution, broke out into sobs, which seemed to amuse M'Manus, but only for a moment. Rhoads and Canning both visited M'Manus previous to the execution, but he refused to retract his resignation as to their guilt. They had quite an exciting interview.
