IT FOLLOWS THE FLAG IT DEFEATED.

Pennsylvania Solid—Butler's Majority Upwards of 60,000.

An Unbroken Line of Northern Republican States—New York, Massachusetts, Nebraska, Illinois, Wisconsin, Connecticut and Others.

These elections have resulted just as every observing man believed they would. The thinking voters of the country have made their choice, casting their votes for that party which for the last twenty years has enacted and guided every measure that has benefited this nation.

The Republican victory is as grand as complete. It means not only victory this year, but assured triumph in the national contest of 1880.

New York elects Com. Republican, Governor by 25,000.

Massachusetts defeats Ben. Butler and elects Long, a true-blue Republican.

Connecticut elects 10 Republican members of the Legislature out of 11.

Nebraska, Illinois, and Wisconsin carry everything with a sweep.

Increased Republican majority in the New Jersey Legislature.

There have been 130 deaths from Yellow Fever in Memphis thus far this season. The cases of the disease number 1,180.

Mr. John Thomas, who owns a farm a short distance from Williamsport, raised 13,000 bushels of potatoes this year from 18 acres, being a little less than 217 bushels per acre.

A destructive fire occurred at Packer, Pa. on Thursday morning, which destroyed about one hundred buildings, entailing a loss of about \$200,000. Many families are rendered entirely homeless.

The fire was the work of an incendiary and started in a small office.

Great damage has been done in the vicinity of Norfolk, N. Y. by recent forest fires, the flames covering thousands of acres. Quantities of timber and staked hay were destroyed, and there is little green timber left. There has been no rain for thirty days. The ground is very dry and the wind high.

A dispatch from Paris says: "The total damage by the recent floods in Spain is estimated at \$9,000,000 francs. Three thousand five hundred houses and 120 mills were destroyed. King Alfonso has subscribed \$500,000 francs for the relief of the sufferers, and the Princess of Austria, \$500,000 francs. The Bank of Spain has collected 60,000 francs for the same purpose."

When Forepaugh's circus arrived in the suburbs of Philadelphia from Elizabeth, N. J., on Thursday last it was found that one of the Bengal tigers was missing from its cage. Two cubs remained behind the bars, but it is not known at what point the beast escaped. During the forenoon the animal was shot and killed about ten miles from the city. It weighed 205 pounds.

The Board of Parolees met at Harrisburg on Tuesday, and agreed to recommend the commutation of the death penalty to life imprisonment in the case of O'Neil, the Northern Ireland county Man Maguire. The Board recommended seven pardons out of forty cases heard at their meeting this week, among them being George W. Giddish, convicted of robbing the "Widow" Oliver's husband, in Harrisburg, in April last. The Board decided to hold its next meeting on Wednesday.
