RESOLUTION Proposing Amendments to the Constitution of the Commonwealth.

Resoluced by the Senate and House of Representa-tices of the Commonwealth of Pennayloguia in Gen-eral Assembly met: That the following amendments are proposed to the Constitution of the Common-wealth, in accordance with the provisions of the tenth article thereof.

There shall be an additional article to said constiaution to be designated as article eleven, as follows

> ARTICLE XI. OF PUBLIC DEBTS.

SECTION 1. The state may contract debts, to sup ply casual deficits or failures in revenues, or to meet expenses not otherwise provided for; but the aggre-gate amount of such debts direct and contingent,

gaie amount of such debts direct and contingent, whether contracted by virtue of one or more acts of the general asignibily, or at different periods of time, shall never exceed seven hundred and fifty thousand dollars, and the money arising from the creation of such debts, shall be applied to the purpose for which it was obtained, or to repay the debts so contracted, and to no other purpose whatever. SECTION 2. In addition to the above limited power the state may contract debts to reped invasion, sup-press insurrection, defend the state in war, or to re-deem the present outstanding indebtedness of the state; but the money arising from the contracting of such debts, shall be applied to the purpose for which it was raised, or to repay such dobts, and to no oth-er purpose whatever.

er purpose whatever. SECTION 8. Except the debts abore specified, in sections one and two of this article, no debt whater er shall be created by, or on behalf of the state.

To provide for this payment of the pres-ent debt, and any additional debt contracted as a-foresaid, the legislature shall, at its first session, af-fund, which shall be sufficient to pay the accruing interest on such debt, and annually to react a sinking fund, which shall be sufficient to pay the accruing interest on such debt, and annually to react the principal thereof by a sum not less than two fun-dref and thy thousand tollars; which sinking fend shall consist of the net annual income of the public works, from time to time owned by the state, or the proceeds of the sale of the sale of stocks owned by the state, together with other funds, or resources, that maybe designated by haw. The said sinking fund name designated by haw. The said sinking fund name designated by haw, or other revenues of the name to time, by assign-ing to ithen y part of the taxes, or other revenues of ing to it my part of the taxes, or other revenues o the state, not required for the ordinary and curren expenses of government, and unless in case of war, invasion or insurrection, no part of the said rinking fund shall be used or applied otherwise than in extinguishment of the public debt, until the amount of such debt is reduced below the sum of five millions s of dollars.

SECTION 5. The credit of the commonwealth shall not in any manner, or event, he pledged, or loaned to, any individual, company, corporation, or associa-tion; nor shall the commonwealth hereafter become a joint owner, or stockholder, in any company, asso-ciation operation viation, or corporation.

SECTION 6. The commonwealth, shall not assume the debt, or any part thereof, of any county, city, borough, or township; or of any corporation or asso-ciation; unless such debt shall have been contracted to enable the state to repel invasion, suppress do-mestic insurrection, defend itself in time of war, or to assist the state in the discharge of any portion of its present indebtedness

its present indebtedness. SECTION 7. The lagislature shall not authorize any county, city, borough, township, or incorporated dis-trict, by virtue of a vote of its citizens, or otherwise, to become a stockholder in any company, association, or corporation; or to obtain money for, or loan its credit to, any corporation, association, institution, or party.

SECOND AMENDMENT. There shall be an additional article to said constitution, to be designated as article XII, as follows :-ARTICLE XIL.

OF NEW COUNTIES. No county shall be divided by a line cutting off over one-tenth of its population, (either to form a new county or otherwise,) without the express asseat of such county, by a vote of the electors there-for: nor shall any new county be established, contain-ing less than four hundred square miles.
