

(Continued from First Page) action appears the more reasonable from the consideration, that if these works, of such evident importance and utility, are not to be accomplished at all by the administration, they cannot be accomplished at all. We have already parted with the power of collecting duties of import in their own ports; and it is not to be expected that they should raise money, by internal taxation direct or indirect, for the benefit of that country; the revenue derived from which, in whole or in part, go into their own treasuries.

Now do I perceive any difference between the power of Congress to make appropriations for objects of this kind, and the power of the states to make appropriations on lakes and rivers, wherever they are large enough to bear on their waters an extensive traffic? The magnitude of Mississippi and its tributaries, and the great lakes of the north, are such that the power of the states over the extension of the power, as far as my knowledge goes, is a mistake to regard as exclusive. Justly, however, the power of Congress is limited by the same causes which have limited the power of the states, and which have been maintained, in the foundations of happiness widely diffused and generally enjoyed, greater than those which fall to the lot of any other nation.

And now, fellow citizens, I cannot bring this communication to a close without invoking you to join me in humble and devout thanks to the Great God of nations, for his goodness and mercy. He has, indeed, loaned us up to us. His hand, so visible in our preservation, has stayed the pestiles, saved us from foreign wars and domestic disturbances, and scattered plenty throughout the land.

The fruits of our labors and toil, have been maintained, the foundations of happiness widely diffused and generally enjoyed, greater than those which fall to the lot of any other nation.
