Cape Palmas, or the "State of Maryland in Liberia," is a settlement of colored people principally from Maryland, who have, since -the establishment of the colony, been supported by the Maryland Colonization Society. They were entirely independent of Liberia until the recent difficulty, when, seeing their Inability to protect themselves' from the attacks of unfriendly tribes around them, asked to be received into the republic of Liberia as a country. A commission was accordingly appointed for the purpose of receiving her. Before the embarkation of the troops on board H. B. M.'s steamer Hecla, which had been sent from Sierre Leon for the purpose of transporting them to Monrovia, Gov. Dravton resigned into the hands of the commission the authority vested in him. 


