PATRIOTIC SPEECH
Hon. Lyman Treman,
 AT A MEETING OF THE DEMOCRACY OF ALBANY, APRIL 22, 1861.

FELLOW CITIZENS—We have assembled this evening pursuant to a call emanating from the Democratic General Committee of the city, to consider the deplorable condition of our beloved country. A state of public affairs exists, equivalent to actual war, with all its stern and terrible realities. Our National Capital is rapidly filling up with armed men, the rumbling thunder of the distant cannon breaks upon the air; martial music is heard in every quarter, from Texas to Maine, summoning men to arms; and our whole country is being rapidly changed into two vast military camps. Growing out of this novel and extraordinary posture of affairs, are new duties and new responsibilities devolving upon the people, and we, as conservative, loyal and patriotic citizens, have met to consult as to the best manner in which these duties and responsibilities may be discharged, for the promotion of the power, the dignity, and the welfare of our country.

JUSTIFICATION OF THE SECESSIONISTS EX AMINED.
 The excuses offered for the acts of violence are that these seven States have availed themselves of their reserved rights under the Constitution, to throw off their allegiance to the General Government, and to renege their right of State Sovereignty by seceding from the Union.

As a peaceful constitutional right, under the Constitution, the right of secession this claimed cannot be conceded. It would strip the Government of all dignity and power; and reduce the Union to a mere rope of sand. The history of the old articles of Confederation, the terms of the new Constitution, its denial to the States of many of the most essential powers of Sovereignty, and the nature and essence of the Government itself, are replete with evidence that the Union is not a mere partnership, liable to be terminated, peacefully, at will, by either one of the States.

POWER OF THE PRESIDENT.
 Congress has the power under the Constitution of the United States, "to provide for calling forth the militia to execute the laws of the Union, suppress insurrections, and repel invasions." When a great public necessity has existed, Congress has enacted laws for the purpose of raising and equipping a militia to meet the occasion, prescribing the number of militia to be called out, assigning to each State its quota, fixing the term for which the President was authorized to accept their services, and making the necessary appropriation to cover the expenses. Such was the course adopted in the Pennsylvania Whiskey Insurrection of 1793, in the War of 1812, and in the war with Mexico, and on various other occasions when serious difficulties were anticipated. The last Congress declined, for reasons which need not be stated, to pass any law for calling out the militia to meet the present emergency.

POSITION OF THE DEMOCRATIC PARTY.
