

which shall be made, under the authority of the United States, shall be the supreme law of the land.

The Senators and Representatives, the members of the several State Legislatures, and all executive, judicial and military officers, both of the United States and of the several States, shall be bound by each and every of the said provisions of this Constitution.

Congress shall make no laws respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

The right of the people to be secure in their persons, houses, papers and effects, against unreasonable searches and seizures, shall not be violated, and no warrant shall issue but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury, except in cases arising in the land or naval forces, or in the Militia, in actual service in time of war or public danger, in which case a person may be subject for the same offence to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty or property without due process of law; nor shall private property be taken for public use without just compensation.

In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the State and district wherein the crime shall have been committed, which district shall have been ascertained by law; and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor; and to have the assistance of Counsel for his defence.

General McClellan in Command. The following is the correct form in which the order with reference to Gen. McClellan has been issued:—

WAR DEPARTMENT, Sept. 2, 1862. GENERAL ORDERS No. 152.

Major-General McClellan will have command of the fortifications of Washington, and of all the troops for the defence of the capital.

The order containing the official notification of the removal of General McClellan from the command of the Army of the Potomac, will be received with great satisfaction by the people of this country.

There is no panic here. All now is calm peace and security.

At noon to-day General McClellan rode out to meet the returning column, and was received with great demonstrations of gratification and pleasure by the army.

Highly important from New Orleans. Special Dispatch to the Philadelphia Inquirer.

Baltimore, Sept. 2.—A gentleman in Baltimore to-day received a letter, dated Aug. 17th, 1862, from Baton Rouge via New Orleans, written by a Federal officer, announcing that the Federal troops had completely destroyed Baton Rouge by fire.

The Federal forces, feeling unable to cope with such overpowering numbers, secured the State archives, and other valuables, and then set fire to the city, leaving it to the flames.

The fire continued burning for three days, destroying, it is supposed, every building. The troops went on board the New Orleans.
