L. V. R. Extension.

The Lehigh Valley Railroad Company's North Branch Extension, building under the charter of Pennsylvania and New York Canal and Railroad Company, between Wilkes-Barre and the New York State line, is open to traffic at both ends, from Wilkes-Barre to Pi-t-ton at the South end, 19 miles, and between Towanda and Waverly at the North end, 16 miles, leaving uncompleted but progressing, 70 miles between Pi-t-ton and Towanda.

It will be seen that 28 per cent. of the entire North Branch division is in operation. When the whole division shall have been opened to traffic, the Lehigh Valley Company will operate 296 miles of main line, from Easton to Waverly, besides its Beaver Meadow and Mahanoy branches. And as the cars of the Lehigh Valley Railroad Co. will run north and northwest to the lakes, and south and east to tidewater, the area of its future operations, bounded by the sea and by the lakes, contains an immense population.

Annual Taxes.

The annual assessment of Internal Revenue taxes for the First Division, comprising Montrose, Bridgewater, Dimock, Lathrop, Springville, Auburn, Irish, Jessup, Forest Lake, Middletown, Friendsville, Apolcon, Little Meadows, Chocoma, Silver Lake and Franklin, is now nearly completed; but a few returns are yet to be received.

In addition to the Special Taxes (formerly called licenses) upon occupations, the annual taxes are those upon incomes for 1887, and upon carriages, gold or gilt watches, plate of gold, and plate of silver, kept for use, and owned or in possession on the 1st of March, 1888.

Those who have made returns showing their liability to income tax are as hereunder—the amount taxable being the excess over \$1,000. In making returns, the income of the wife and minor children is included:

Officers of the U. S. Government are subject to income tax; but the amount is deducted from their salary, and is not entered upon the assessor's list.

Upon every watch composed in whole or in part of gold or gilt, the tax is \$1; and if the value exceed \$100, the tax is \$2. Those who have reported watches marked with a * have watches taxed at \$2.
