Taking up then the second article he said the temporary designation of a person to discharge the duties of an office until the office could be filled, was made legal by the act of 1795, which, he is satis-fied, has not been repealed by that of 1863. But even if he thought otherwise, Mr. Grimes said he should be unable to convict the President of a crime in such a temporary appointment, not doubting but that he said in good faith and believed he was acting within the laws. He dismissed the conspiracy articles very briefly, as he did also the eighth and ninth articles.

He then took up the question of intent. saying he had no doubt that the Presisaying he had no doubt that the Presi-dent thoroughly believed the tenure of of-fice act was unconstitutional, and said that he was advised of its unconstitutionality by Mr. Stanton and other members of the Cabinet, and Mr. Grimes thought it not strange that under the circumstances the President should doubt or question its scope. He held, however, that Stanton's case was not included in the provisions of intent need not be considered, as the President had done no unlawful act.
