Interesting Biblical Statistics. The Odor of Flowers. Many of our lady gardeners are doubtless looking forward with eager anticipation to the time when they will be released from close rooms and confined apartments, and can have a good time around their garden walks, trimming borders, planting slips and seeds, and preparing for the summer campaign among the roses.
