The Democratic vote is attributed in part for a want of all the resources and means of political success in which the Republicans are strong. There was neglect as well as inefficiency in the management of the Democratic cause. But none of this neglect is chargeable to the Republicans. They were organized for the contest as early as May when their nominations were made in Lancaster, while the Democrats had but seven weeks' time for organization. They had abundance of money, official patronage, political power, all the resources, while the Democrats had none of these. Yet in three years the default of the Republicans of Pennsylvania is double that of the Democrats. Both parties were miserably far from equal in the contest, while the Democrats had none of these. A SCHEME TO GOBBLE THE TREASURERSHIP.

We have been aware for some months of a scheme set on foot by the county Treasurers of Philadelphia, Schuykill, and Luzerne counties, to gobble the office of Treasurer for another year longer than the people elected them for, by a fanciful technicality under the new state constitution, and that they have been in communication with other outgoing "country" Treasurers to enlist them also in the scheme.

About forty in number have combined for the purpose and have subscribed money to a fund for employing counsel to present their scheme before the state court, and since election we learn that E. G. Taylor, the present Treasurer of this county, is one of that number. We should have alluded to this subject before the election but for the reason that we had no idea that Mr. Taylor would attempt to usurp the office one more year than the people elected him for, under any circumstances, and as he was not a candidate we did not desire to present him in that light before the people. Since the election we have learned from his own mouth, that he intends to do so if it were possible for him and the "Ring" are bracing him up to it.

Whether this scheme would ever have appeared to the people of this county had George S. Smiley been elected, never can be demonstrated and of course must now forever remain unknown, but the province of conjecture, of course, is a legitimate subject for the taxpayers of this county.

The point raised is this. Under the new constitution, Treasurers are elected for three years, while under the old constitution they were elected for but two, and Mr. Taylor was elected before the new constitution was adopted, and the election proclamation of the "High Sheriff" proclaimed to the people that a Treasurer was to be elected for two years, and the people voted for him upon that basis, but the new constitution having since been adopted the claim is that this technicality gives him the power to hold on to the office another year. What can the people think of such a usurpation after the election by one of a successor? If the "Ring" or Mr. Taylor had informed the people before the Sheriff's proclamation for 1875 had been issued or our county conventions had made their nominations, of their intentions (which we denounce as the basest of technical tricks), there would be more show of reason and honesty than now. We have no belief that a court of this Commonwealth can be persuaded or packed to decide in their favor, upon a point so hostile to common sense and every principle of justice, yet the very attempt in them is just as worthy of popular indignation as if they could succeed. What can the people conclude in the case in this county, only that the "Ring" will attempt to hold their power for ever: when they are reprobated by the people? Can this be claimed as a charge made by us when their own action has placed them in that light before the people? We leave it for them to explain.
