THE APRIL TERM OF COURT.—This term of Court was very sparsely attended. Out of a civil list of thirteen cases only two were tried—the remainder being continued, discontinued, settled, nonsuits taken and judgments given by consent. But two bills were before the Grand Jury in the Sessions. One was ignored—in the other a true bill found and defendant acquitted. The jury trials were not commenced till Tuesday morning and were over by Wednesday evening. The argument list and miscellaneous business occupied the whole of Thursday till a late hour in the night—when the court adjourned sine die.

Argument List. Jacob Spade vs Jeremiah Bruner and William Carl.—Rule to show cause why judgment should not be entered for defendant notwithstanding verdict.

Same vs. same.—Rule to show cause why judgment should not be entered against the defendant Jeremiah Bruner notwithstanding verdict or why a new trial should not be granted. After an elaborate argument by counsel on both sides held under advisement.

Administrators of James Dunn, dec'd., vs. Margaret Charters.—Rule to show cause why judgment for want of appearance and affidavit of defence should not be opened 27th April, 1871. Rule made absolute, but upon the terms that the debt should not plead the statute of limitation.

T. J. Middagh, pff in error, vs. Samuel Murphy, etcetera to E. W. H. Kreider, Esq., 27th April, 1871. Deft in error having entered a nol pro in the appeal taken by William Young, this judgment against T. J. Middagh is affirmed.

John Landis, agent, and pff in error, vs. Peter Nyman.—Certificate to Jesse Reed, Esq., 27th April, 1871. Judgment reversed.

J. C. Powell, pff in error, vs. Com. of Pa.—Certificate to E. W. H. Kreider, Esq. Proceedings affirmed.

In the matter of the application of John McManigal for a license to keep a public house in the borough of Perrysville. Rule to show cause why the license granted at February term should not be revoked. 24th April, 1871. Rule discharged, and it is directed that the fees of the witnesses be paid by the party who subpoenaed them or directed them to be subpoenaed.

In the matter of the petition of the Court of Quarter Sessions for the appointment of auditors to settle the differences between Delaware township and Thompsonburg borough. The jurisdiction being in the Common Pleas and not in the Quarter Sessions, the proceedings were set aside.

Overseers of Delaware township vs. Overseers of Greenwood township. Argued and held over.

Lewis A. Landis vs. Jeremiah Lyons and Henry Cross, assignees, &c.—This was a feigned issue deduced by the Court in an attachment execution to determine whether the pff in issue was entitled to certain moneys and goods claimed under the \$300 exemption law. April 25, 1871, verdict for deft.

James Crouse vs. William M. Allison.—This was an action of replevin brought by pff to recover from deft a male, without hair, blind of an eye, hoof bound, afflicted with the hooves, and that could not be driven or coaxed, sold at constable's sale as the property of B. F. Crouse, and bought by deft. Pff alleged that the male was not the property of B. F. Crouse, but that he was the owner by virtue of a sale made shortly before levy, to which deft replied that the sale was fraudulent. The case was very vigorously contested, and resulted in a verdict for deft of \$675, the value of the mule, on which a judgment of de retorero habendo was entered.

James W. Allen, executor of Samuel Allen, dec'd., vs. McNair Wilson.—Judgment by consent for pff of \$950.

Quarter Sessions. Com. vs. John Winn.—Indictment, assault and battery. Bill ignored, and that J. English West, the prosecutor, pay the costs.

Com. vs. Rachel Quay.—Indictment, assault and battery. True bill. Tried and acquitted. County to pay the costs.

JAMES M. MASON, of Virginia, died near Alexandria Va., on the night of the 25th. He belonged to the Calhoun school of Democrats previous to the rebellion, in which he figured as a rebel.—He held places of honor and profit previous to the rebellion. Aged seventy-three years.
