EXTRACTS FROM THE MORNING POST

Interfering from Mexico.

The New Orleans papers received at Richmond, contain no less news.

The President learns from sources entitled to all credit, that Gen. Pierce did not leave Vera Cruz on the 17th, but expected to leave on the evening of the 18th.

The Governor of Vera Cruz received fully satisfied of the intended attack on the city and had taken all necessary precautions to guard against a surprise.

The letters to the President say nothing of the force collected at the National Bridge on the 20th of the troops under Gen. Pierce.

Letters received at Vera Cruz from the capital, from authentic sources, more positively than Santa Anna is in favor of peace, and only waiting for the peace party to gain the undisturbed ascendancy before he declared himself.

It was unknown at Vera Cruz whether the commissioners appointed to treat with our commissioner, had been appointed by Santa Anna or by Congress; or, indeed, whether Congress had assembled at all.

It was understood there, that Congress had been summoned to assemble on the 7th.

The names of the Commissioners reported there, were Turner, Parilla, Parella, and Garcia. The Molinero, Baranda, is represented as a creature of Santa Anna.

The Sun of Anahuac says that the Commission represents the heart of Santa Anna; and was therefore decidedly favorable to the opinion that Santa Anna favors peace.

The Arco Aris of the 13th says, that the Commission had accepted their appointment, and had departed on the discharge of their duties.

It also states that this course was approved by a majority of the more influential citizens, who in a great degree contributed to its adoption.

One letter mentions, as being appointed on the commission, General Canales, of Vera Cruz, whom Santa Anna had received into favor.

It was stated that no change in the ministry had taken place, and that a majority of the ministers were in favor of an armistice of our difficulties.

The Picayune gives a speech of Gen. Canales, and the reply of Gen. Taylor, made at dinner at the Walnut Springs on the 4th of July; and also the toasts and speeches of Col. Wright, Gen. Canales, and Gen. Taylor, on the same day.

L. L. Fuller, the Massachusetts volunteer, gave as a toast—

General Taylor—We hail him as our next President; his course in that station, he has brought to a happy and successful close.

To which Gen. Taylor responded—

Mr. President, gentlemen—I have never had the vanity to aspire, or look forward, to the elevated position, which has just been alluded to; but if my fellow-countrymen think proper to elect me to so distinguished and honorable a position, I certainly will do my best to discharge the duties of that responsible station faithfully; and if any other candidate is preferred and offered to them, I will not object.

Myself, I need not say that I acquiesce most cheerfully in the decision; and will rejoice that there is one esteemed more worthy to represent them in the highest office in their gift.

The news news received concerning our former Secretary of the arrival of Gen. Pillow at Puebla on the 8th, which it is thought had a tendency to favor negotiations for peace. Gen. Scott, on the 11th, commenced his march towards the capital.

The commercial Times says that a French gentleman, who had languished on the 6th, declared that the Mexican Congress had met; and that they were assembled; but that nothing was known thereof at the appointment of Commissioners.
