Organization of Territorial Government—General's Message—Message to Santa Fe.

LAZARUS, January 11, 1864.
Dates from Santa Fe, and New Mexico, have been received nearly a day later than former advices. The Legislature of New Mexico had adjourned, and Capt. Angey, elected Speaker of the House of Representatives, Senator Antonio San David has been elected President of the Senate.

The message of Gov. Vigil was sent to the Legislature; but it is of little interest. A bill passed authorizing the election of delegates to take into consideration the annexation of that country to the United States.

Gen. Price arrived in Santa Fe on the 12th, and constituted Mr. Vigil Civil Governor of the Territory.
