If this be true, there can be no kind of doubt as to the result; but we are still ully satisfied that, even without the vote of New York, our ticket will be triumphantly sustained. As a matter pertinent to these remarks; as going o show the state of public feeling in relation to the nomission we present the following extract from a letter from the city of Washington, just received:---"General Cass, of Michigan, the great defender of scountry's cause, whether against the British inhis country's cause, whether against the British in-vasion of our country in the last war, British en-croachments on the freedom of the seas, British encroachments in Oregon, or Mexican usualt and inva-sion. The Vice Plesident laid before the Senate a communication from Gen. Cass, tendering his resigna-tion. The Senate ordered the Vice President to no. tify the Governor of Michigan of the vacancy.

A message in writing was received from the President, enclosing a petition from the citizens of Oregon, asking the aid of the General Government, and recommending the subject to the favorable consideration of Congress. Referred to Committee on Military Affairs, of which Mr. Benton is made Chairman in place of Gen. Cass.

On motion of Mr. Crittenden, the Indiana appropriation bill was taken up and amended. The Bill was then laid aside, and the most of the day devoted to business of little importance. House. Mr. Tuck moved a suspension for the purpose of bringing in a bill providing for the abolition of slavery in the District of Columbia. The motion was lost: yeas 53, pays 89.

The Speaker then called the several States in order for Resolutions.
