#### DISSEMINATING OPINION OF JUSTICE LOWRIE.

RAILROAD SUBSCRIPTION CASE.  
The Hon. J. R. Lowrie, Chief Justice of the Supreme Court of the State of Pennsylvania, has rendered the following opinion in the case of the Pennsylvania Railroad Company vs. the State of Pennsylvania.

The case arises out of a bill introduced into the Pennsylvania Legislature, which provided for the purchase of the Pennsylvania Railroad Company by the State of Pennsylvania. The bill was passed by the Legislature, and the Governor signed it into law. The Pennsylvania Railroad Company then brought suit in the Supreme Court of the State of Pennsylvania, claiming that the bill was unconstitutional, and asking for an injunction to prevent the State from purchasing the railroad.

The Chief Justice, in his opinion, held that the bill was constitutional, and that the State was entitled to purchase the railroad. He based his decision on the fact that the railroad was a public utility, and that the State had a right to regulate it. He also held that the bill did not violate the Constitution of the State of Pennsylvania.
