REMOVAL.—The bill which has passed the Legislature, directs the keepers of public houses, restaurants, and other institutions, where the inmates are supported at the public expense, to deliver, on application, to the trustees or teachers of any school, college or other institution, provided the bill is not demanded for the purpose of a religious or sectarian institution, within 24 hours after death.
