Mr. Webster's Reception at Boston, was highly enthusiastic. At a public meeting, he entered into a frank discussion of the financial affairs of the country. gave some excellent views on the mutual dependence of all clauses of the people upon each other, and scouted the idea that any one interest could be elevated on the destruction of other interests. He referred to the compromise tariff, and intimated that this subject would probably soon engross the attention of Congress and of the people at large, and concluded by adverting to the nomination of General Harrison, and declaring that the nomination would receive not his reluctant or sollen acquiescence, but his hearty co-operation and support!

So much for the prognostications of our country's enemies, who asserted that Daniel Webster would not yield his hearty concurrence to the Harrisburg convention.

Public Lands .- The abject dependence of Governor Porter on the views of the general government, is well exemplified by his total silence on the subject of the public lands. While the aspirants for the Presidential succession are willing to sacrifice the property of the original states in the national domain. and Gov. Porter is recommending direct taxes to pay the interests of our state debt, there is not a movement made to save the share of Pennsylvania, which would nearly liquidate that debt, and prevent this direct levy on the property and farms of her citizens! The territory is held in trust by Congress for the benefit of all the States, and yet Benton, Calhoun, and other aspiring politicians, would wrest it from the " original thirteen, " and bestow it as a bribe to secure the suffrages of the new states. While man States of the old confederacy are adopting legislative enactments, condemning in the strongest terms this breach of trust, our Executive does not raise his voice. His course is plainly this: let the west have the public domain of our state to enrich the party and place Van Buren's successor' on the throne; the people of the Keystone will suffer themselves to be taxed, to pay the interest of their debts, and by annually increasing it seven millions, the whole people can be placed in servile dependence on the loco foco party! Is there a man, with ordinary perception who does not see the end of such policy! With a subtreasury bill, passed against the expressed wishes of a large majority of the people-with a people louiled with grivous taxes to support the State and general governments—with a specie currency for the office holders, and depreciated bank paper for the democracy of the nation, which can at any time be made worthless by the extraordinary operations of that sub-treasury scheme-with all these means at amended as to require the meeting of the Legislature command, how easy is the transition of our country on the second Tuesday of November in each year. from a republic to a monarchy ! Pennsylvania Legislature. SENATE.

THURSDAY, January 9, 1840. The Senate was occupied in the early part of the day, in the same manner as the House, with the Governor's veto messages, and other public documents. Mr. FRAILEY of Schuyfkill, read in his place, a bill for the relief of the Union Canal Company, and also in relation to the Danville and Pottsville rail road

Mr. BROWN of the county, read in his place, a bill repealing the charter of the United States Bank, and showing it one year to wind up its accounts. Henry Buehler was elected Clerk, and appointed Daniel K. Kaine as his assistant. John Stahl received the majority of votes for Sergeant at Arms, and John P. Junes Door keeper. Boas & Coplain were elected printers of the English Journal, Babb & Hummel of the German Journal, and the Keystone, the

House of Representatives:

The Secretary of the Commonwealth being intro duced, presented various messages from the Governor. among which were vertoes to the following Bills, passed at the last session of the Legislature, viz: The Bill making appropriation for widening the Union Canal, and also to the Danville and Pottsville

Also, the Bill making an appropriation of \$7,000 to the Milesburg and Smithport turnpike road compa-Also, the Bill for the establishing of a State Luna-

Also, the Bill for the relief of James Frazier and And also, the Bill incorporating the City of Alle

These being returned to the House in which they originated, were taken up agreeably to the Constitu tion for the purpose of giving them a trial upon their final passage by a vote of two thirds; but they were all postponed for the present without a vote, for the purpose of further examination.

Mr. McELWEE opposed the postponement of some of them on the ground that they were iniquitous. He said they all understood them well enough that the Governor after having almost a year's consideration had given his opinion, and that was sufficient. He thought they should act upon, and kill them immedialely. Mr. DARSIE of Allegheny, said he wished to say

a few words in explanation of the vote he should give upon this question. He said he should vote in favor of this bill and in favor of every other Bill which had been returned with the Executive Veto. He was opposed to this extraordinary abuse of Executive power, believing that it was intended only to be used in case of great emergency. He should vote for the passage of the Bills upon pure Democratic principles. He looked upon these Bills as having the sanction of a majority of both houses of the Legislature of 1838, and he would presume in the absence of other proof, that they liad not given them that sanction without having been persuaded of their merits. He could not give his vote to sanction the interposition of an arbitrary power upon an occasion so little contemplated by the framers of the Constitution. He would support the decision of the popular Branch of the Legislature as being more Democratic than the arbitrary will

or opinion of any Executive. Ultimately the bill was lost on its formal passage 18 yeas 70 navs.


