For regulating, curbing and paving the side walks and gutters in parts of Centre and Railroad Streets.

Section 1. Be it ordained and enacted, by the Town Council of the Borough of Pottsville, and it is hereby ordained and enacted by the authority of the electors of the Borough of Pottsville...
