TO THE TAXPAYERS OF SCHUYLKILL.

THE County Commissioners are directed to call the attention of the Taxpayers, to the provision of the Act of the 23rd of April, 1814, which provides that if any county shall pay into the State Treasury, its quota of the State Tax, on the first day of August, in any year, such county shall be entitled to an abatement of five per cent on the amount so paid, and any State Tax remaining unpaid by any individual or Corporation, after said tax has been paid by said county, shall be a lien on the estate on which it is charged, till fully paid and satisfied.
