

The Coal Trade for 1846.

The quantity sent this week is 54,472 tons, being an increase over last week. Unless unusual accidents should occur, the quantity will continue to increase weekly hereafter.

The estimate for April, was 90,000 tons—the quantity during the month of April, 100,000 tons. It is estimated that for the year have been exceeded upwards of 600.
