The quantity sent by Rail Road this week 75,000 tons by Canal 3,500 tons total for the week 78,500 tons.

The great freight in the Schuylkill and the heavy rains in this region has lessened the trade this week.

The rates of toll on Canal were increased ten cents per ton on the first toll, and the Rail Road Company has also advanced its rates of toll and transportation also, ten cents per ton.
