Terrible Mining Accident—Death of Six Miners

Terrible Mining Accident—Death of Six Miners, and Injury of Several Others.—A terrible accident happened on Friday of last week at the red sah colliery of George H. Potts & Co., near Miners-ville, which resulted in the death of six miners and injury of others who attempted to rescue them. It seems that on Wednesday afternoon the miners made a blast in one of the breasts, to cause a fall of coal. The fire by some means communicated to the combustible matter in the mine, driving the miners out of the mine. On Friday six miners named Thomas Richards and David Williams, Welshmen: Joseph Bearman afterman, and Robert Duffy, Michael Finney and Michael Scully, Irishmen, went into the mine to clear away the rubbish. Their prolonged absence created alarm and fear that something had happened to them, and other miners sent in to see what was the matter, were prostrated by the noxious gas that filled the place, and were with difficulty dragged alive from the mine. Finally, on Saturday morning the dead bodies of the six men named above, were found and taken from the mine.—The Coroner held an inquest on Sunday last, and a verdict was rendered that the deceased came to their deaths from suffocation.

All of the unfortunate men were steady, industrious miners, and some of them lave families. Scully was the father of twenty-one children by one wife.
