In Ireland, all the negroes against the protection of subjects against the abuse of arbitrary power are withdrawn. There is no law against constructive treason, as in this country. Indeed, the treason laws of England severe as they are, are not extended to Ireland. It is not treason, but felony and burglary, to conspire against the British Government. That is to say political offenders are treated like log-pickers and thieves, and are liable to be dogged and arrested by every policeman and detective. It is under this law, sweeping and cruel in its operation, that John O'Donovan and the other Fenians have been sent to the chain-gang of Australia.

Under these laws it is no wonder that all the prisoners acted as if they knew that their cases were pre-judged from the first. They made admissions and conducted themselves toward the judges in a manner that showed they expected to be hanged, and they were not. So far from manifesting any actual conviction, so far from manifesting any acquiescence with a defiance of their judges and with enthusiasm for their cause. This is the inevitable result of the laws which are the principle of the spirit of the age and the principles of justice. Of course, England assumed the right from the power of cannon, all the blood with the mouths of cannon, all the question her rule. Whatever may be her question and sympathy for foreigners, in the South, in Italy, France and any other countries, she never exhibits any mark of sympathy for domestic rebels.
