The in-come lists are nearly all, by this time in the hands of the Assessor of the Incernal Revenue. The law declares that they shall all be presented be-fore the last day of May, and the taxes paid before the 30th of June. But in country districts, it is impossible to comply strictly with this provision. Hence necessity has compelled the Assessor in those districts to take their time, and they rarely have the whole of their part of the business tran-soried before the first of July. We therefore, suggest that if any citizen has neglected to make return of his income, that he do so forthwith. 


